

Corporate Compliance Update-Adverse Benefit Notice and COVID-19 Scam

 - Legal Reminder Adverse Benefit Notice is a written notice that a benefit/service is being terminated and is required by federal law. The notice is to be sent by mail before the service/benefit is terminated. It can be hand delivered to the recipient of the service or guardian, or legal representative but must be documented, dated.
 - Backdating is UNETHICAL and ILLEGAL.
 - > COVID-19 Scam Alert Medicare and Medicaid, elderly and disabled, and those who LifeWays serve can be targeted. I.E. A telephone call informing of a COVID vaccination shortage that requires personal identifying information and credit/debit card info. How can we help? • Vaccination Overview – Courtney Sullivan

There is a decrease in numbers. Variants from other countries are being reported as more contagious. All precautions must be continued including mask wearing. Discussion with clients regarding the safety and effectiveness of the vaccinations is beneficial. The CDC provides the correct information to share. Daily Reporting

Daily reporting has been very helpful to keep track and subsequently provide support if needed. Daily reporting has been on the decline but is still necessary and LifeWays will follow-up with those providers who have not been providing the reports.

2. Residential Monitoring

• Alarms – Wheelchair and Bed

Make sure alarms are in working order and in good order, i.e. battery replacement when needed. When site visits are done these alarms will be checked as part of the review.

Staff meetings

Clear communication, especially during COVID time, to staff is necessary and very important so that all are aware of what is happening in the homes. Staff meetings need to be documented and will be reviewed during the site visit.

• Demonstrating on the job training

On the job training is important and required. This is in addition to the Relias training.

Standing medical orders must be followed and documented by staff.

• CPI transition to QBS Safety Care

Scheduling will be posted for all others requiring the new training. Safety Care is a six-hour long training and will be offered on Thursdays and Fridays at LifeWays.
