# What's New?

Welcome to the November edition of Self-Direction Delivered (previously Self-Determination Delivered). My name is Stephanie Justice, and I would like to formally introduce myself as the new Self-Directed Services Coordinator. I am honored and delighted that I have the opportunity to work with such dedicated individuals. Along with providing support and guidance to our consumers, guardians, and family members as they make the important decision to live life to the fullest, the way they CHOOSE!

You may notice that language has changed relative to "Self-Determination." These changes are due to the update in the State of Michigan's Technical guide for "Self-directed Services." Self Determination will now be called "Self-Directed Services" or, "Self-Direction." You will notice that my position is now called the Self-Directed Services Coordinator as a result of this change. Another notable change occurred with the "Fiscal Intermediary" where we are now expected to refer to this as "Fiscal Management Services."

LifeWays would like to provide Self-Directed Employers a quick update on the status of the extension of the COVID-19 \$2.00 premium payments. An extension of the supplemental payment has been approved for face-to-face, direct care through January 9, 2021.

Overnight Health and Safety (OHSS) is not available for individuals residing in licensed settings. Payment of OHSS may not be made directly or indirectly to responsible relatives (i.e., spouses or parents of minor children) or a legal guardian.

To be eligible for OHSS, an individual must:

• be Medicaid eligible;

• be enrolled in one of the following waiver programs: CWP, HSW, or SEDW;

• be living in a community-based setting (not in a hospital, Intermediate Care Facility for Individuals with Intellectual Disabilities or ICF/IID, nursing facility, licensed foster care, correctional facility or child caring institution); and

• require supervision overnight to ensure and maintain the health and safety of an individual living independently.
